

**TURKEY CUP WAIVER 2021**  
**Release and Liability Waiver – Media Usage Permission**

This release is intended to discharge in advance FC Frederick, Inc., and their officers, agents, and employees from and against any and all liability, including for negligent actions, arising out of or connected in any way with my or my minor child’s participation in the TC21.

KNOWING THE RISKS OF PARTICIPATION, NEVERTHELESS, I HEREBY AGREE THAT I ASSUME THOSE RISKS AND RELEASE AND HOLD HARMLESS FC FREDERICK, INC., AND THEIR OFFICERS, AGENTS, AND EMPLOYEES WHO (THROUGH NEGLIGENCE OR CARELESSNESS) MIGHT OTHERWISE BE LIABLE TO ME, MY MINOR CHILD (OR OUR HEIRS OR ASSIGNS) FOR DAMAGES.
